I. CALL TO ORDER/WELCOME: The meeting was called to order by Mayor Butler at 6:00pm.

II. ROLL CALL- CITY CLERK: All members were present, which constituted a quorum.

III. CITY MANAGER'S REPORT: Shalonda Brown

City Manager introduced the new employees to the City of Forest Park.

Past Events – The City's Holiday Parade was held on Dec. 5, 2020; Employee Holiday Luncheon on Dec. 14, 2020; Wreath Across Forest Park on Dec. 18, 2020 and Shop with a Cop Annual Event on Dec. 17, 2020. Continued prayer for Clyde Lee's family, he was a 40 plus year employee in the Public Works Department and was funeralized on Dec. 23, 2020; 2nd Annual Wreath Laying Ceremony in honor of Officer Richard Cash was held earlier today, Jan. 4, 2021.

In the last Council meeting a re-opening plan for the City was to take place on January 11, 2021, however, due to the increasing numbers of COVID-19, we will not be opening to the public, but all City staff will resume their normal work schedules and report back to work effective January 11, 2021. The Fire/EMS Departments will present a comprehensive pandemic plan at the Feb. 1st Council meeting.

Upcoming Events – M. L. King Parade will be held Sat., January 16th at 11:00am, City Hall will be closed on Mon., Jan. 18th in observance of the M. L. King Holiday; Wellness with Wells, every Tuesday at 6:00pm; Food Truck Fridays will return on Jan. 8th; and Ward 1 Neighborhood Meetings will resume on Thursday, January 21st at 5:00pm.

Councilmember James – Spoke on the Wreath Across Forest event.

IV. COVID-19 UPDATE: Fire Chief, Don Horton, Division Chief, Joel Turner and Deputy Chief Latosha Clemons

The COVID-19 numbers continue to rise statewide. The same is true within the city. The current average rate of daily positives among those tested statewide is 17.7% on for the past two weeks; 6.9% higher than two weeks ago. As of today, 1/4/2021:

• Clayton County's average rate of daily positives is 18.7%, 5.9% higher than a couple of weeks ago, and still higher than the state's two-week average.

As reported by Clayton Co Health District this morning also: 1/4/2021

• Forest Park currently has 1,426 cumulative cases; 9.6% of county cases on the 30297 zip, a reduction of 1%; with approx. 26 active cases currently within incorporated FP, nearly twice as many as two weeks ago.

We encourage everyone, more than ever, to follow good personal hygiene practices - wash hands frequently, use hand sanitizer, maintain physical distancing, and use masks, even in situations where you can distance.

If you have not already gotten a flu shot, now is the time to do it. Some authorities feel that a minimum of 3-4 weeks after receiving the influenza vaccine is necessary, before receiving the COVID vaccination. This will help in reducing the number of respiratory infections as the weather has turned colder. The vaccination is covered by most major insurance providers and is available through most pharmacies or professional medical providers.

COVID Vaccinations are here! These vaccinations have been designed to not only trigger the body's own immune response to develop antibodies, but also to aid in making the virus ineffective once it enters the body. Last Tuesday, Dec. 29th, some of our Fire Department responders began receiving the Pfizer vaccine through a cooperative effort of Forest Park Fire and Emergency Services, Forest Park EMA, Clayton County District Health, Clayton County Fire and Emergency Services, Clayton County EMA, and Southern Regional Medical Center. Our Law Enforcement partners will begin receiving their vaccinations through the same pathway within the next few weeks. Our Medical Director, Dr. James Augustine, MD, is also helping lead the way by receiving the first dose of his vaccination today. And I am scheduled to receive the first dose of my vaccination series this Friday, 1/8.

Public vaccinations planning is also underway, and we anticipate being able to institute these plans in the next few months. Forest Park Fire, EMS, Rec & Leisure, and Clayton County Health District are currently working on developing these plans for the public. These may include walk-through and drive-through capability for dispensing the vaccinations. Specific details of these Points of Distribution will be released later, when appropriate.

The City continues to take necessary precautions to protect employees from contracting the virus by workplace transmission. The Fire Department has developed, and all city departments

have implemented, a Sick or Exposed Employee Flowchart. In brief, this flowchart will help Department Heads determine the proper course of action for their employees who may become sick or experience an exposure to someone who is sick. The flow chart accounts for necessary testing at appropriate intervals and provides guidance on how long employees must remain out of work and when they may return.

Additionally, all city departments have instituted the use of a commercial grade sanitizing sprayer and solution. The process of building sanitizing at a minimum will be every Friday afternoon, or the last weekday before a holiday break, and any time an employee becomes sick while at work and may pose an exposure risk to their coworkers.

Councilmember Wells – Keep who we have, have not had any issues with the three (3) elections she has held (inaudible)

Councilmember Gutierrez – Why is this on the agenda?

Mayor Butler – This has come up in our retreat and we kept who we had in place and now it is time to make an appointment, and if we chose to go with Ms. Wright, then that is the direction Council chose to go and if we want to go in another direction, this is the time to do so.

Councilmember James – I would recommend that we put it out to select those interested in applying the position of Election Superintendent and Deputy Superintendent.

Councilmember Gutierrez – Why are wanting to change? I understand there were some complaints, but they were from candidates that did not win. Do we just like to rotate?

Councilmember James – I would prefer that we discuss in Executive Session.

Councilmember Wells – City Attorney, can we discuss in Executive Session?

Attorney Williams – You are not required to, but this particular subject can be discussed in Executive Session.

3. Discussion to Appoint Deputy Election Superintendent

Comments/Discussions from Council:

Councilmember Wells – I think once we decide on an Election Superintendent, they should be involved in this process to get someone that is qualified to do the job.

Councilmember Gutierrez – For clarity, the Election Superintendent is the one that oversees the whole process? And the Deputy is the helper?

Councilmember Wells – Responded yes

4. Discussion to approve a Resolution to set and publish qualification fees for the 2021 General Election for the Offices of Mayor, and Council Wards 1, 2

Background and Summary:

Title 21 of the Official Code of Georgia requires that qualification fees for public offices are fixed and published no later than February 1.

Comments/Discussions from Council:

Councilmember Mears – Do we see any need to increase or decrease the standing amounts?

Attorney Williams – This is more a housekeeping deal; because the Statue sets the fee at 3% of the preceding salary for each position and we are required to publish the fees prior to Feb. 1^{st} .

5. Discussion to Appoint Development Authority Board Member(s)

Comments/Discussions from Council:

Councilmember James – I would like to recommend Dexter Hartsfield to the Development Authority to the vacant seat on the board.

6. Discussion to Select Pension Plan Option- Shalonda Brown, Interim City Manager

Background and Summary:

GMA Pension Plan staff will prepare documents for the Governing Body's approval once the City decides which plan, they will select. This item will be placed on the regular agenda once we receive the documents from GMA.

Comments/Discussions from Council:

Councilmember Antoine – (inaudible)

Councilmember Wells – (inaudible)

Councilmember James – This was a discussion on our recent Work Session. What the full impact of the finances will be on the City. We were discussing in the Retreat stopping the current plan and starting this plan, but I still fell we need more information on how this will impact the city and would like to table to have more meetings on this.

Councilmember Wells – I was not in attendance at the December Special Call Meeting, so is there someone here that could possibly answer Councilmember James' questions?

City Manager – Yes, there was a representative from GMA, Michelle Warner, gave us information with the different fees. For them to do the actuary, we had to have a percentage to prepare, which was 1.5% and 2.5% to compare the cost to the city. Each time to do an estimate, there is a cost of \$2,500 fee. At the rate of 1.5% the cost to the city was \$512,663. If we do a 1% multiplier, we will need them to give us the cost. I spoke with the representative from Empower, the amount the City contributes as a total is \$368,002.66 currently, so if we do the Pension at the 1.5% multiplier it would be an increase; the 1% may be lower or a wash out.

Mayor Butler – The estimate rate of return on 7.25%, so any time the stock market falls below that percentage the city would have to make up the difference and that is something we must consider.

Councilmember Gutierrez – This is something that is occurring across the state, a lot of cities and municipalities have. Recruiting for new employees is hard because other cities have more benefits/pension plans are stable benefit plan. I am in favor of pension plan. At 1.5% would yield for 20 years and employee would get 30% of their salary.

Councilmember Antoine – We cannot control stock market it goes up and down. We are talking about investing in our employees.

Councilmember Wells – We have employees who have been working for the city 30 plus years and do not want to leave, because the city does not want to offer them a plan. I agree with Councilmember Antoine, there is nothing to debate about when we are investing in the people that make our city move.

City Manager – We do have a 457 Compensation Plan for the employees.

Councilmember Antoine – (inaudible)

Mayor Butler – I would like to have our Finance Director in place. I am for investing in our employees, but think it is very critical that we look at all avenues.

Councilmember James – Have there been conversation with the employees about this?

City Manager – I have spoken with the employees from a HR standpoint and as City Manager. They are excited about the opportunity of having a Pension

Plan. I have explained that we may not keep the 457 Plan, but they can keep it and have all the savings to themselves. Because with the 457 you can borrow, with the Pension Plan you cannot borrow.

Councilmember James – I am not against the Plan, but it is to make sure that we are able to do it. There are other cities who have had a Pension Plan and had to stop it, but they included some form of employee contribution oppose to the city covering the entire cost.

Councilmember Gutierrez – What will that look like? I do not want this to fall by the wayside, since this has been something discussed two years ago, what more information do you need?

Councilmember James – Would like a comparison as to what the cost would be to the city if we something like the 457 Compensation with some type of employee contribution. There was a fee explained, where if employees are not participating, the city would pay a certain amount, which is a substantial amount what the city would pay if employees were or were not participating. How does that look, what do it mean? If an employee decides they do not want to participate, does the city continuing to pay? I am not trying to debate but just need more information. I agree with Councilmember Wells about the Council, I do not think Council should be a part of Pension Plan, the focus is on the employees.

Councilmember Antoine – We are employees also, so I disagree with that. The information is here, there is representative from GMA that share all the data, this is where it comes down to approving or not. Attorney Williams, is there some type of legislation that we can pass not approving Council to be included in Pension Plan?

Attorney Williams – You do not have to accept the Pension Plan.

Further discussion was inaudible due to multiple persons speaking.

Attorney Williams – Staff will need some direction on how to move forward.

Councilmember Wells – We need to decide which option we are going with?

7. Discussion to approve Volunteer Day Leave- Councilman Hector Gutierrez

Background and Summary:

It is proposed that a paid day off for employees be offered once a year so that they may volunteer for Philanthropic or charitable cause.

Councilmember Gutierrez spoke on why he would like to see the employees have a day of paid leave to volunteer in the city.

Comments/Discussions from Council:

Councilmember Antoine – My suggestion is on the One-Day Volunteering, if we set up hours for volunteering which would encourage employees to volunteer.

Councilmember Gutierrez – I would like to see three (3) days per calendar year set up, but not knowing the cost to the city, this is just the initial discussion and can have another discussion later

Councilmember Antoine - This could cost the city a lot, but if we add instead of each day, just one day, and every extra day would go to volunteering, which would add up your volunteering needs/account, and the amount you get from the account, makes you eligible to go volunteer. You have that one day, but you have employees that volunteering is second nature to them. So, they would submit paperwork for volunteering to add on the volunteering hours, separate from the city volunteering hours, with hope that they would gain enough volunteering hours to meet what the City has set for number of days and they would be eligible to go on a mission trip.

Mayor Butler – Are you suggesting the City pay for a mission trip?

Councilmember Antoine – Yes

(There was further discussion on how to set up the Volunteer Day for employees)

Attorney Williams – The City Manager and staff can put together guidelines for a One-Day Volunteer Day in the City of Forest Park that documentation. Beyond that, we would have to put something together for Council to review and agree upon.

This item will be brought back to the new meeting.

8. Discussion to adopt ORDINANCE 2021-01 the Temporary Loans: authorizing the temporary loans by the City of Forest Park, under the Constitution of the State of Georgia; Article 9, Section 5, Paragraph V. - Attorney Mike Williams.
