- 1. Consider an Agreement with the City of Forest Park and Motorola Solutions, Inc.

Background and Summary: On October 1, 2019, Forest Park's Public Safety Communications System and many of its mobile and portable radios will reach "end of life". Based on this information, the City Council approved an Inter-governmental agreement with Clayton County on August 19, 2019. This agreement allowed the City of Forest Park access to the Clayton County Public Safety Data Network (PSDN). The Clayton County Board of Commissioners approved the Inter-governmental agreement on October 1, 2019. Through the Services Delivery Strategy (SDS) and an Inter-Governmental Agreement, Clayton County has agreed to incur all costs related to infrastructure maintenance with the exception of the equipment necessary for the City of Forest Park to maintain its own 911 Communications Center and the radios necessary to communicate on Clayton County's PSDN. Motorola is the current public safety communications vendor for Clayton County and Forest Park. They assessed both systems and have proposed an agreement to provide access to Clayton County's PSDN and to upgrade the Fire/EMS department's radios for \$244,085.10. The related lease purchase agreement allows this

balance to be paid in seven (7) annual installments, with the first payment not being due for twelve (12) months. If SPLOST is approved by the voters in March 2020, the equipment can be funded through SPLOST. If SPLOST is not approved by voters, funds will come from the unappropriated balance of the general fund.

Background and Summary: Mrs. Cathy Babb Johnson is requesting a street named in memory of her dad Cpt. Harold Babb of the Forest Park Police Department for 32 years who passed away with lung cancer 07/14/2006. Mrs. Johnson's mom was told a street would be named after Mr. Babb and possibly in the Rosetown Community. The family is asking that the City honor Mr. Babb by naming a street in his memory.
