SUMMARY AND BACKGROUND

DeKalb County has an area in the Southwest corner of their County (Grant Rd-Ellenwood) that consists of two residential subdivisions where the entrance is in Clayton County while the homes are in DeKalb County. The closest DeKalb fire station is approximately seven miles away while the closest Forest Park fire station is only two miles away. The DeKalb Fire Chief has asked the City of Forest Park to enter into an agreement where the City would respond to this defined area to begin initial attack on fire incidents with the DeKalb units relieving the City units upon their arrival as needed. In return DeKalb County agrees to provide its training facility and pump testing facility at no cost to the City a minimum of two times a year.

INTERGOVERNMENTAL AGREEMENT FOR THE PROVISION OF FIRE AND RESCUE SERVICES BETWEEN

DEKALB COUNTY, GEORGIA and THE CITY OF FOREST PARK, GEORGIA

THIS INTERGOVERNMENTAL AGREEMENT, by and between DeKalb County,

Georgia ("County") and the City of Forest Park, Georgia ("City") entered into this day of, 2018.
WHEREAS, DeKalb County, Georgia is a constitutionally created political subdivision of the State of Georgia; and
WHEREAS, the City of Forest Park is a municipality City organized under the Laws of the State of Georgia, acting by and through its duly elected City Council; and
WHEREAS, the Georgia Constitution, ARTICLE IX, § 2, ¶3 prohibits cities and counties from exercising certain governmental authority within each other's boundaries except by intergovernmental Agreement or as otherwise provided by law; and
WHEREAS, the County and City desire to enter into an Intergovernmental Agreement for the City to provide fire suppression and support assistance within specific boundaries of the County and for the County to provide access to the County Fire Academy facilities to the City for a period commencing upon execution of this Intergovernmental Agreement ("IGA").
WHEREAS, the County and the City further desire to establish that the agreed upon services and access provided by the County to the City and by the City to the County shall be at no additional costs pursuant to this Agreement; and
WHEREAS, the County and the City desire to maintain a mutually beneficial, efficient and cooperative relationship that will promote the interests of the citizens of both jurisdictions; and
WHEREAS, the County and the City have authorized the execution of this IGA through

ARTICLE 1

NOW THEREFORE, in consideration of the following mutual obligations, the County

appropriate Resolutions adopted by their respective governing bodies,

and City agree as follows:

PURPOSE AND INTENT

1.1 The purpose of this Agreement is for the City to provide fire protection assistance within specific areas of the County, as indicated in Attachment A, which is attached hereto and hereby incorporated into this IGA.

- 1.2 The City therefore agrees to provide the County with services consistent with the overall quality of services provided throughout the County, with additional services as prescribed in Attachment A attached hereto and hereby incorporated into this IGA.
- 1.3 The County therefore agrees to provide the City Fire Department access to the County Fire Rescue fire training facility located at 3161 Warren Road Decatur, Ga at least twice (2) each calendar year, subject to availability.
- 1.4 Pursuant to O.C,G.A. 25-6-5, there shall be no liability imposed on the County of DeKalb, Georgia or the City of Forest Park, Georgia for any action or failure to act as a party of this Agreement.

TERM OF AGREEMENT

- 2.1 The initial term of this Agreement shall commence on the 1st day of at 0000 hours and concluding at 2400 hours on 31st day of December, 2028. This Agreement shall automatically renew on January 1st of each successive year for a total of ten (10) years concluding at 2400 hours on December 31, 2028 unless terminated by either party.
- 2.2 The parties agree that, either party may terminate this Agreement at any time during the term of this Agreement upon no less than ninety (90) days written notice to the other party. Nothing in this article shall preclude termination pursuant to Article 7.

ARTICLE 3

COUNTY FIRE DEPARTMENT SERVICES

- 3.1 The County Fire Department shall respond appropriately to all incidents within the jurisdictional boundaries of the County regardless of the response by the City Fire Department and will relieve the City Fire Department as soon as practical.
- 3.2 The County Fire Department will make the fire academy facilities to include the seven-story fire tower, the burn building, the cistern, and apparatus driving course available to the City Fire Department upon request at least twice a year.
- 3.3 The County Training Chief will coordinate the accessibility of the training facility with the City Fire Chief, Training Chief or designee at least two (2) weeks in advance of the date the training will occur.
- 3.4 The County shall furnish the water and burning materials used during the training exercises conducted by the City without costs to the City.

ARTICLE 4

CITY FIRE DEPARTMENT SERVICES

4.1 The City Fire Department will automatically respond and utilize City resources when providing fire suppression services in the contiguous geographic service area of DeKalb County, on a continual 24-hour per day basis in accordance with Georgia law, County Ordinances, and City

Ordinances. These services shall be provided within the jurisdictional boundaries of the County, as described in Attachment A.

- 4.2 The City Fire Department will respond with an engine or unit with fire suppression capabilities with a minimum of three (3) firefighters to all calls-for-service related to fire suppression within the specific jurisdictional limit of the County as described in Attachment A, as dispatched through the 911 system.
- 4.3 The City Fire Department engine shall make every reasonable effort to maintain an emergency response time target of eight (8) minutes or less, 90% of the time.
- 4.4 Incident supervision, including the provision of standby equipment, will be as prescribed in DeKalb County Fire Rescue Standard Operating Procedures, until the City is relieved with qualified County fire personnel.
- 4.5 The City shall provide uniformed firefighters, of any rank, with the City's own standard support equipment necessary to carry out the fire suppression and fire protection functions contemplated by this Agreement.
- 4.7 The City shall furnish and maintain in good working condition all necessary emergency communication facilities and equipment necessary and proper for the purpose of performing the services, duties and responsibilities described in this Agreement.

ARTICLE 5

RECORDKEEPING AND REPORTING

- 5.1 The County Fire Department is the central repository for all departmental records and makes available public records as defined by the Georgia Open Records Act, O.C.G.A. § 50-18-70, *et seq.* During the term of this Agreement, the County will continue to maintain all reports relating to Fire Department activity within the County.
 - 5.2 Except as limited by any provision of state or federal law, the County may request, review and access data and City records to ensure compliance with this Agreement.
 - 5.3 The City Fire Department shall document incidents within the DeKalb County using the equipment and records management system (RMS) provided by the City Fire Department.

ARTICLE 6

EVENT OF DEFAULT

- 6.1 An event of default shall mean a material breach of this Agreement by the County or City as follows:
 - 6.1.1 The City consistently fails to meet the levels of service outlined in Article 4, which failure has been communicated in writing by action of the County to the City on more than one occasion.

- 6.2 An event of default shall mean a material breach of this Agreement by the County as follows:
 - 6.2.1 Failure of the County to make available access to the County training facility as stipulated in Article 3.

TERMINATION AND REMEDIES

- 7.1 Except as provided in Article 2 concerning termination by either party following 90 days' written notice, the City or County may terminate this Agreement in the event of default, unless the default is cured as provided in this article.
- 7.2 If an event of default occurs, in the determination of the City, the City shall notify the County in writing, specify the basis for the default and advise the County that the default must be cured to the City's reasonable satisfaction within a 60-day period. The City may grant additional time to cure the default, as the City may deem appropriate, without waiver of any of the City's rights, so long as the County has commenced curing the default and is effectuating a cure with diligence and continuity during the 60-day period, or any longer period which the City prescribes.
- 7.3 If an event of default occurs, in the determination of the County, the County may notify the City in writing, specify the basis for the default and advise the City that the default must be cured to the County's reasonable satisfaction within a 60-day period;. The County may grant additional time to cure the default, as the County may deem appropriate, without waiver of any of the County's rights, so long as the City has commenced curing the default and is effectuating a cure with diligence and continuity during the 60-day period or any longer period which the County prescribes.
- 7.4 In the event that either party breaches a material term or condition of this Agreement, other than an event of default, the party in breach, upon receipt of a written request from the non-breaching party, shall remedy the breach within 30 days of receipt of the request. If the breach is not cured within the specified time period, the non-breaching party may utilize the remedies of declaratory judgment, specific performance, mandamus or injunctive relief to compel the breaching party to remedy the breach.
- 7.5 The parties reserve all available remedies afforded by law to enforce any term of condition of this Agreement.

ARTICLE 8

AMENDMENTS

This Agreement, including the designated service area, may be modified at any time during the term by mutual written consent of both parties, as approved by the parties' governing authorities in writing.

NOTICES

All required notices shall be given by first class mail, except that any notice of termination shall be mailed via U.S. Mail, return receipt requested. Notices shall be addressed to the parties at the following addresses:

ARTICLE 10

NON-ASSIGNABILITY

Neither party shall assign any of the obligations or benefits of this Agreement.

ENTIRE AGREEMENT

- 11.1 The parties acknowledge, one to the other, that the terms of this Agreement constitute the entire understanding and Agreement of the parties regarding the subject matter of the Agreement.
- 11.2 The attachments referred to and annexed to this Agreement are made a part of this Agreement.

ARTICLE 13

SEVERABILITY

If a court of competent jurisdiction renders any provision of this Agreement (or portion of a provision) to be invalid or otherwise unenforceable, that provision or portion of the provision will be severed and the remainder of this Agreement will continue in full force and effect as if the invalid provision or portion of the provision were not part of this Agreement.

ARTICLE 14

BINDING EFFECT

This Agreement shall insure to the benefit of, and be binding upon, the respective parties' successors.

ARTICLE 15

COUNTERPARTS

This Agreement may be executed in several counterparts, each of which shall be an original, and all of which shall constitute but one and the same instrument.

ARTICLE 16

THIRD-PARTY BENEFICIARIES

This agreement shall not be construed as, or deemed to be, an agreement for the benefit of any third party or parties. No third party or parties shall have any right of action hereunder for any cause.



SECTION 1. Designation of Meeting Times. The City Council hereby adopts the schedule of meeting times, dates and locations for its work sessions and regular meetings as shown on the attached Exhibit A.

SECTION 2. Public Record. This document shall be maintained as a public record by the City Clerk and shall be accessible to the public during all normal business hours of the City of Forest Park.

SECTION 3. Authorization of Execution. The Mayor is hereby authorized to sign all documents necessary to effectuate this Resolution.

The City Clerk is authorized to execute, attest to, and seal any documents which may be necessary to effectuate this ordinance, subject to approval as to form by the City Attorney. **SECTION 5. Effective Date**. This resolution shall become effective immediately upon its adoption by the Mayor and City Council of the City of Forest Park as provided in the City Charter.
