Discussion: Forest Park Small Business Relief Grant Lois Wright provided the board with brief overview of the proposed Forest Park Small Business Relief Grant.

The Forest Park Small Business Relief Grant was developed by the Economic Development Department on behalf of the Development Authority. The purpose of the grant is to assist small businesses in Forest Park, which have suffered revenue loss and financial

uncertainty due to the Covid-19 Pandemic. The grant program will award fifty (50) small businesses in Forest Park with \$2,000 to offset their business expenses. These expenses can include, but aren't limited to, payroll, rent, and operating costs.

The grant would be available to businesses in Forest Park with an active 2020 business license in the City and no more than ten (10) employees. Applications would be processed by Danita Hamid, Economic Development Assistant and award recipients would be selected at the board's discretion.

The investment total for this program would be \$100,000, but \$50,000 would be reimbursed through the Clayton County CDBG fund.

## Approval of the Forest Park Small Business Relief Grant Program

Eliot Lawrence made a motion to approve the proposed Forest Park Small Business Relief Grant with an investment of \$100,000 to provide fifty (50) \$2,000 awards to small businesses in Forest Park, with \$50,000 to be reimbursed through the Clayton County CDBG Fund.

Pamela Lake seconded the motion. Motion approved unanimously.

## Discussion: Use of the Community Center

Lois Wright informed the board that the Mayor and Council were interested in using the upstairs of the community center as a broadcasting space.

She explained that she would have more information for them about this matter in the next meeting.
