ARTICLE 5 – MANDATORY PRE-BID CONFERENCE

5.01 A MANDATORY PRE-BID CONFERENCE will be held at 11:00 AM EST on Friday.

December 17, 2021 at the City of Forest Park City Hall, City Council Meeting Room located at 745 Forest Parkway, Forest Park GA, 30297. A site tour is scheduled immediately following the Pre-Bid Conference. Representatives of Owner and Engineer will be present to discuss the Project. Bidders are required to attend and participate in the conference since this meeting is mandatory. Engineer will transmit to all prospective Bidders such Addenda as Engineer considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective.

ARTICLE 6 – SITE AND OTHER AREAS

6.01 The Site is identified in the Bidding Documents. Easements for permanent structures or permanent changes in existing facilities are to be obtained and paid for by Owner unless otherwise provided in the Bidding Documents. All additional lands and access thereto required for temporary construction facilities, construction equipment, or storage of materials and equipment to be incorporated in the Work are to be obtained and paid for by Contractor.
