YARD SALE REGULATIONS

GENERAL

- 1. ONLY THE OWNER OR TENANT OF RESIDENTIAL PROPERTY SHALL CONDUCT SALES. NO MULTI-FAMILY SALES NOR SALES ON COMMERCIAL PROPERTY EXCEPT AS SPECIFIED IN ORDINANCE SECTION 9-8-1 OF THE CITY CODE
- 2. ONLY **THREE (3) YARD SALES ALLOWED A YEAR** FROM JAN-ARY THRU DECEMBER. SALES ARE LIMITED TO A CONSECUTIVE THREE-DAY PERIOD.
- 3. ITEMS TO BE SOLD MUST BE MERCHANDISE THAT BELONGS TO THE SELLER AND NOT ITEMS WHICH WERE PURCHASED FOR RESALE.
- 4. SELLERS ARE TO BE HELD RESPONSIBLE, ENSURING SHOPPERS DO NOT IMPEDE PEDESTRIAN AND/OR VEHICULAR TRAFFIC.
- 5. PERMIT IS ONLY GOOD FOR THE DAYS SPECIFIED ON THE PERMIT AND CITY ISSUED SALE SIGN.
- 6. IN THE EVENT OF INCLEMENT WEATHER OR OTHER ACTS OF GOD, SUCH PERMIT MAY BE VALIDATED AT CITY HALL FOR USE ON COMPARABLE DAYS, WITHOUT THE PAYMENT OF ANY ADDITIONAL PERMIT FEE.
- 7. PERMIT MUST BE KEPT AT THE SALE SITE FOR INSPECTION BY ANY CITY OFFICIAL.

SIGNS:

- 1. ONLY THOSE SIGNS ISSUED BY THE CITY FOR "YARD SALES" ARE ALLOWED AND SHALL BE LIMITED TO TWO (2) SUCH SIGNS PER YARD. ALL OTHER SIGNS PROMOTING OR ADVERTISING GARAGE SALES, RUMMAGE SALES OR YARD SALES ARE PROHIBITED. THE TWO SIGNS PROVIDED BY THE CITY MAY BE PLACED AS FOLLOWS:
 - **ONE** CORNER DIRECTIONAL SIGN MAY BE DISPLAYED ON PRIVATE PROPERTY WITH THE PRIVATE PROPERTY OWNER'S PERMISSION
 - ONE SIGN MAY BE DISPLAYED ON THE PROPERTY AT THE PLACE OF SUCH SALE
 - NO SIGNS MAY BE PLACED ON UTILITY POLES OR ON TRAFFIC SIGNS
 - NO SIGNS MAY BE PLACED ON CITY RIGHT-OF-WAYS, OR WITHIN (5) FIVE FEET OF ANY STREET, HIGHWAY, OR SIDEWALK
 - NO SIGN MAY BE PLACED ON CITY PROPERTY

• BOTH SIGNS ARE TO BE REMOVED BY SELLER AT THE END OF THE SALE
