City of Forest Park CDBG Governors Drive Sidewalk Project

&

Rockcut Road Drainage and Sidewalk Project

The City of Forest Park is requesting proposals for the design of approximately 545 LF of sidewalk on Governors Dr. from Forest Parkway to the end of the City roadway and approximately 2700 LF of drainage and sidewalk improvements along Rockcut Road. Final documents should include engineering and construction documents showing specified, right of way plans, crosswalks and handicap accessible ramps and sidewalks. Each job location must be priced separately

Design plans should show a five foot sidewalk with a two foot grass strip, where right of way is available, otherwise sidewalk will be five foot wide from the back of curb.

Proposal will include the following:

- Preliminary site visit to assess proposed improvements, establish a reasonable
 understanding of the scope of the project, the character of existing development
 along the proposed alignment corridor and the nature of the problems to be
 anticipated in connection with the utilities, right-of-way considerations and other

- 2. Final concept and Preliminary Engineering Field Review
- 3. Topographic Mapping: This will include all of approximately 545 linear feet of the project area on Governors Dr. and 2700 linear feet along Rockcut Road and also include information for the entire area of proposed sidewalk addition, thirty (30 feet) on each side of the centerline, existing above and underground utilities, existing pavement, existing curb and gutter and the closest, existing down stream stormwater structure in each direction. Contour intervals should be shown every two feet. The surveyor will clearly mark on his plans and in the field spot elevations, benchmarks, bearing, distances and datum used to collect data. The work shall include deed research as required to locate all structures and describe the City of Forest Park Right-of-Way for the project.
- 4. Civil Engineering Design and Construction Documents:
 - Roadway plan sheets shall provide horizontal layout based on existing roadway alignment, grading and drainage and shall provide all proposed improvements;
