- 4. A copy of a survey plat of the property;
- 5. A written legal description (in metes and bounds);
- 6. **A conceptual site plan.** This plan must be drawn to scale and must depict the proposed use of the property. This must include the following:
  - A scale and north arrow;
  - The proposed land use and building outline as it would appear (should the Conditional Use Permit application be approved);
  - The present zoning classification of all adjacent parcels;
  - The gross square footage of all proposed buildings;
  - The proposed location of all driveways and entry/exit points for vehicular traffic, using arrows to depict direction of movement;
  - The location of all required off-street parking and loading spaces, including number of spaces and driveway dimensions;
  - Required yard setbacks (appropriately dimensioned);
  - The location and extent of required buffer areas, depicting extent of natural vegetation, as well as the type and location of additional vegetation (if required).
- 7. File notarized application and all required materials with the City of Forest Park Department of Planning & Community Development.
- 8. Pay application fee. The Conditional Use Permit application fee is \$250. The fee is due upon submission of this application. Please make check payable to The City of Forest Park.

#### **Procedures of Obtaining a Conditional Use Permit**

- Conditional Use Permit is submitted with all accompanying required documents and a nonrefundable application fee of \$250.00.
- 2. The Planning Commission members will be notified by the Secretary of the Commission of the scheduled public hearing time and date.
- 3. The applicant will be notified by email or phone of the date, time, and location of the public hearing.
- 4. An advertisement of the public hearings will run in the legal section of the Clayton News Daily newspaper for 2 (two) weeks.
- 5. Subject property will be posted with a sign by the Department of Planning & Community Development, advising the general public that a Conditional Use Permit application has been filed, and of the meeting date, time, and location of the meeting.
- 6. The Planning Commission will hold a public hearing to consider the Conditional Use Permit application.
- 7. The Planning Commission will then forward their recommendation to the Mayor and Council.
- 8. A second public hearing will be held at the next scheduled council meeting and Mayor and Council will consider the Conditional Use Permit application and render a final decision during the regular scheduled meeting that same night.
