The permanent sign permit fee is based off the square footage of the sign

Sign Area (Square Footage)	Fee
1 to 10 Square Feet	\$50
11 to 25 Square Feet	\$75
26 to 50 Square Feet	\$100
51 to 100 Square Feet	\$150
101 to 200 Square Feet	\$250
201 to 300 Square Feet	\$500
301 to 500 Square Feet	\$750
501 to 700 Square Feet	\$1,500

The temporary sign permit fee is tiered (30 days, 60 days, or 90 days)

Tiers	Fee
Tier 1 (30 Days)	\$25
Tier 2 (60 Days)	\$50
Tier 3 (90 Days)	\$75
